# Major-Specific and Transfer Pathway Articulation Agreement Communication

The Department of Communication in College of Humanities at the University of Utah (UofU) and the Division of Communication and the Performing Arts in the School of Art, Communication and Media at Salt Lake Community College (SLCC) agree to the articulation of transfer credit as outlined in this major-specific articulation agreement.

Nothing in this Agreement shall require either party to carry different or additional insurance. It is not the intent of either party to incur by contract any liability for the operations, acts, or omissions of the other party or any third party and nothing in this Agreement shall be so interpreted or construed. In the event of any conflict, inconsistency or discrepancy between the provisions of this paragraph and any other provisions of this Agreement, the provisions of this paragraph of the Agreement shall govern.

This agreement will remain in effect unless terminated in writing by either institution. This agreement will be reviewed annually, and renewal is contingent on the outcome of this review.
